

2022 ELECTRIFICATION REBATESEFFECTIVE JANUARY 1, 2022

Electrification rebates are available to active Holy Cross members in good standing who heat primarily with natural gas or propane. Invoices must be within 90 days of applying for rebate. All rebated equipment must be installed in Holy Cross service territory and be working before applying for rebate.

Maximum rebate amounts are per account per year. Limit of \$6,000 per account per year including bundle rebate.

ELECTRIFICATION (FUEL SWITCHING – RETROFIT ONLY)

Bundle Rebate

• Home envelope (see residential rebates) + cold climate heat pump + heat pump water heater: \$1,000 bonus

Criteria:

- All three projects must be completed within 90 days of each other
- Send email to rebates@holycross.com with all three invoices. Apply for each rebate separately at https://www.holycross.com/rebates/

Cold Climate (ductless or ducted) Heat Pump

Rebate amount: 25% of project cost up to \$4,000 Criteria:

- Home is heated with natural gas or propane or new construction with no gas or propane
- Ducted: HSPF 9+; Ductless: HSPF 10+
- Compressor must be variable capacity (three or more distinct operating speeds, or continuously variable)
- Must be rated for cold climates and provide heat down to 5°F or lower
 - Recommend investing in hyper heat (Mitsubishi), low ambient or extra low temperature heat pumps that heat to -13°F or lower
- Load calculation required to right size outside unit and derate for high elevation
- Must be used as primary heat source in the home

Heat Pump Dryer

Rebate amount: 25% of the cost of the dryer up to \$100 Criteria:

- Replace natural gas or propane dryer or new construction with no gas or propane
- Energy-Star certified dryer with heat pump technology

Heat Pump (Hybrid) Water Heater

Rebate amount: 25% of project cost up to \$1,000

- Criteria:
 - Existing water heater is natural gas or propane or new construction with no gas or propane
 - Hybrid/electric heat pump water heater models only
 - Energy Star rated

Induction Cooktop/Range

Rebate amount: 25% of project cost up to \$100 $\,$

Criteria:

- Existing cooktop/range is natural gas or propane or new construction with no gas or propane
- Induction cooktop or range only

New All-electric Homes (no gas or propane installed)

- Qualify for electrification rebates
- Qualify for solar and battery rebates
- Does not qualify for bundle rebate





Transportation and Lawn Care

E-bike

Rebate amount: 25% of the cost of the e-bike up to \$50 Criteria:

- E-bike must be new; no rebate for resale or converting bike to e-bike
- E-bike must offset vehicle miles
- Electric scooters, mopeds, Segways or motorcycles do not qualify for rebate
- Limit of 2 e-bike rebates per household lifetime

Electric Vehicle (EV)

Residential: free level II ChargePoint charger

Commercial: Holy Cross is partnering with local businesses to provide cost-effective workplace

E-Lawn Care

Rebate amount: 25% of the cost of the e-lawn care product up to the maximum amount listed below

- Electric mowers (push or riding) and snow blowers -- \$150
- Electric chainsaws -- \$100
- Electric trimmers, pruners, leaf blowers and power washers -- \$50/each

Criteria:

- New equipment only
- Battery or corded electric equipment only
- Minimum purchase price of \$50
- No resales allowed
- Equipment must be used in Holy Cross' service territory
- Maximum rebate \$300 per year per member
